**Condition of Sales Agreement and Guarantee**

Each puppy has been examined by a veterinarian while in our care and it is to the best of our knowledge that each puppy is healthy and free of genetic defects. Each puppy from *Made for TV Doodles* is being sold with limited, dual GANA and CKC Registration and are sold as companion pets where as we do not make any guarantees as to the disposition, conformation, breeding ability, nor a determinate adult weight. By signing the spay/neuter contract, the buyer is agreeing to get their new puppy spay or neutered by 1 year of age unless breeding rights are purchased and that is stated in this contract. If breeding rights are not purchased, the buyer will send a copy of the veterinarian record once the spay/neuter is complete. (Not doing so will void this sales contract.) If breeding rights are purchased, breeder does not guarantee the ability, disposition or outcome of breeding the puppy and will not cover any costs associated with such. The buyer has a duty to take their puppy to a licensed veterinarian within 7 business days of receipt of the puppy. If buyer neglects this duty, the health guarantee becomes null and void. Do not give your puppy any vaccinations within the first 10 days of arrival, doing this will also void this contract.

The health guarantee provided to the buyer is not inclusive of any injuries, problems, or health issues caused by the actions or neglect of the buyer or subsequent owners. The guarantee does not cover some conditions that are considered normal in some breeds (including but not limited to hypoglycemia (low blood sugar), cherry eye, entropion, loose hips, and skin allergies or luxating patellas). The guarantee does not cover hip dysplasia if your puppy has been spayed, neutered, bred, overweight, or over-exercised.

Buyer listed in this contract is accepting responsibility for the care of this puppy in its entirety for the life of the puppy. This includes but is not limited to: maintaining a proper diet and sensible weight for the breed, size and age. Buyer agrees to provide regular and proper care including heart worm prevention, age appropriate vaccinations, and exercise.

**Until the dog is two (2) years of age, the breeder agrees to replace the dog if any of the following circumstances occur AND all of the conditions of this agreement are met and maintained.**

If your puppy is diagnosed with a genetic defect that makes your puppy unsuitable to be a companion, the purchaser must notify the breeder within 10 days and provide the breeders veterinarian with any and all x-rays and reports used to confirm diagnosis of the puppy. If a life-inhibiting, genetic defect is confirmed, the puppy must be seen and diagnosed, at the buyer's expense, by two veterinarians not affiliated with each other and the breeder's veterinarian must concur with the diagnosis. The puppy's papers, health records and reports from the veterinarian, and a signed statement stating the date of the exam and all alleged health risks on the veterinarian's letterhead before action will be taken. It is at the discretion of the breeder as to whether the replacement will be monetary, 50% of the price of the puppy not including transportation, or in the means of a replacement puppy.

All transportation arranged by buyer is at the expense of the buyer and is not covered by the breeder, nor will the breeder be responsible for any delays, inconvenience or financial loss, or any refunds due to transportation. Venue and jurisdiction for litigation arising out of or related to this breeder shall lie exclusively in Tarrant County, Texas with said litigation determined by the laws of Texas notwithstanding any conflict of laws principles. If the breeder is determined the prevailing party in any litigation, the breeder shall be entitled to recover attorney fees, costs, and expenses.

This agreement represents the entire agreement between the parties and the parties represent that each is not relying on any other agreements other than this agreement. The parties can modify this agreement in writing signed by each party.

The original of this form must be mailed by Certified Mail within 10 business days of puppy's arrival to validate this contract in its entirety. Failure to return the agreement renders the same null and void, including all guarantees made herein. Please feel free to keep a copy for your records and mail this original and a copy of your vet's receipt back. Thank You.
